What Data do we collect?

We collect the following data:

- Personal identification information (Name, email address, institution)
- Your abstract

How will we use your data?

Implementation and submission of abstracts, inclusion in the programme booklet, list of names and institutions of participants (hereinafter referred to as list of participants), contact for publication of contributions and information on last-minute changes.

Legal basis

- Execution and confirmation of the submission of the abstract:
Art. 6 para. 1 lit. e GDPR in connection with § 3 HG NRW.

Recipient

- First and last name, institution: (without information on telephone and e-mail) List of participants/program. The program will be printed and available for visitors during the event. In addition the program will be published on the HS Gesundheit homepage and will be stored there after the event. Thus it will be accessible for users of online and print media worldwide.

Duration of storage

- Until the event has been completed, i.e. approximately three months after the last day of the event the data will be deleted.
- Exceptions to this are the first and last name and the institution included in the program. The program is archived in the event archive of the HS Gesundheit.

Your rights

Based on the processing of your personal data, you are entitled to the following rights:

- in accordance with art. 15 GDPR to request information about your personal data processed by us. In particular, you can request information about the purposes of processing, the categories of personal data, the categories of

recipients to whom your data has been or is or will be disclosed, the planned storage period, the existence of a right to rectification, erasure, restriction of processing or objection, the existence of a right of complaint, the origin of your data, if it has not been collected by us, as well as the existence of an automated decision-making, including profiling, and, where applicable, meaningful information about the details thereof;

- in accordance with art. 16 GDPR immediately to correct inaccurate or complete your personal data stored by us.
- in accordance with art. 17 GDPR to request the erasure of your personal data stored by us, unless the processing is necessary for the exercise of the right to freedom of expression and information, for compliance with a legal obligation, for reasons of public interest or is necessary for the assertion, exercise or defense of legal claims;
- to request the restriction of the processing of your personal data in accordance with art. 18 GDPR, insofar as the accuracy of the data is disputed by you, the processing is unlawful, but you refuse to and we no longer need the data, but you want to use it for the purpose of asserting, implementing or assertion, exercise or defense of legal claims or you object to the processing of your data pursuant to art. 21 GDPR have objected to the processing;
- in accordance with art. 20 GDPR to receive your personal data that you have provided to us in a structured, legal and machine-readable format, or to request the transfer to another responsible party;
- in accordance with art. 7 (3) GDPR to revoke your consent once given to us at any time. This consequence that we may not continue the data processing based on this consent in the future. We would like to point out that the revocation of consent will not affect the lawfulness of the processing carried out on the basis of the consent until the revocation.

Responsible supervisory authority according to art. 77 GDPR

Furthermore, you have the right to informally contact the competent supervisory authority for data protection at any time and to complain. Generally, you may contact the supervisory authorities of your usual place of residence or workplace or the State Data Protection Commissioner of North Rhine-Westphalia under the following contact data contact:

II. Information about your right to object according to Art. 21 (1) DS-GVO
